Keynote Speakers



MAJOR KIMBERLY A. LANE, MSW

Maj Kimberly A. Lane is the Mental Health Flight Commander for the 35st Operational Medical Readiness Squadron, Misawa Air Base, Japan. Maj Lane leads 26 military, civilian, and contract personnel enabling mental health, substance abuse, domestic violence, and 24-hour crisis diagnosis, treatment, and support to 7,000 beneficiaries. In this capacity, she ensures the delivering 8,300 appointments a year.

Maj Lane grew-up in Old Bridge, New Jersey. She entered the Air Force in July 2010 following graduation from the University of Southern Mississippi. During her career, she has held every leadership position within the mental health flight. Her experience includes direct response to the Route 91 Harvest Music Festival shooting, key to the Aviano AB's 2020 National Surety Inspection Superior Team, and numerous enterprise benchmark practices.

Maj Lane also provided joint-service leadership and health services under combat conditions while deployed in support of Operation ENDURING FREEDOM in July of 2012 until January 2013. She is married to (R) CMSgt John W. Lane.

Andrew Badcoe is a mental health counselor, Gestalt-oriented therapist and clinical supervisor working with and within the international community in Tokyo, around Japan and abroad. He received his postgraduate Advanced Diploma of Relational Gestalt Psychotherapy from Gestalt Therapy Australia and holds a Bachelor of Social Work (Honours) degree from the University of Melbourne. Before relocating to Japan in 2018, Andrew worked for many years as a clinical (hospital) social worker, counselor and supervisor within diverse interdisciplinary care settings, especially psychosocial oncology, palliative care, gastroenterology, Addiction Medicine and Aboriginal Health.

Currently Andrew works with adolescents and adults in private practice, and serves as Lead Supervisor at TELL Lifeline. He also provides CPR / First Aid skills instruction to individuals, schools and corporations on a part-time basis. He is a Psychotherapy and Counseling Federation of Australia (PACFA) Certified Counselor, a member of the Australian Association of Social Workers (AASW) and a Registered Instructor with MFA Japan / MEDIC First Aid.

She is currently working at TELL Counseling Okinawa as a psychotherapist.
